Shrimp Stir Fry

4 oz cooked shrimp peeled, deveined
1 1/2 cup(s) packaged coleslaw mix
(shredded cabbage and carrots)
2 medium uncooked scallion(s) chopped
2 Tbsp teriyaki sauce
1/2 cup(s) long grain cooked brown rice

Combine shrimp, slaw, scallions and teriyaki
sauce in a skillet; toss and heat through.
Serve over rice.

Jerk Turkey Slow Cooker Soup

1/4 tsp ground allspice
1/4 tsp cayenne pepper
1/2 tsp ground ginger
1/2 tsp garlic salt
1/2 tsp black pepper, divided
1 lbs uncooked boneless skinless turkey
breast, cut in 1-inch chunks
1 clove garlic clove(s), minced
1 medium uncooked onion(s), chopped
14 1/2oz canned diced tomatoes, fire-roasted
with green chilies, undrained
15oz canned black beans, drained & rinsed
2cups canned chicken broth
1/2 tsp table salt
1/2 Tbsp fresh lime juice (1 Tbsp)
2 Tbsp cilantro, fresh, minced

1. In a medium bowl, combine
allspice, cayenne, ginger, garlic salt
and 1/4 teaspoon of black pepper.
Add turkey and toss to coat; set
aside for 15 minutes.
2. Place turkey in a 5-quart slow
cooker; add any spices remaining in
bowl. Add garlic, onion, tomatoes,
beans, broth, salt and remaining 1/4
teaspoon of pepper; stir. Cover and
cook on low setting for 6 to 7 hours.
Stir in lime juice and cilantro; let sit
for 5 minutes for flavors to blend.

Claims that Could Affect You

Mirena – is an IUD that was originally approved by the FDA as an intrauterine contraceptive. It was later approved as a treatment for heavy menstrual bleeding. Serious adverse side effects and potentially life-threatening complications have been reported following the implantation of the device. These complications include organ perforation, migration of the IUD to outside the uterus, expulsion of the IUD, and embedment in the uterus, among others.

IVC Filters – Retrieval IVC filters are wire devices implanted in the vena cava, the body's largest vein, to stop blood clots from reaching the heart and lungs. These devices are used when blood thinners are not an option. Manufacturers include Bard, Cook and Johnson & Johnson. While permanent IVC filters have been used since the 1960s with almost no reports of failure, retrieval IVC filters were introduced in 2003, promoted for use in bariatric surgery, trauma surgery and orthopedic surgery. Risks associated with the retrieval IVC filters include migration, fracture and perforation, leading to embolism, organ damage and wrongful death.

3M Bair Hugger – is a force hot air warming blanket, used to help maintain a patient's body temperature during surgery. It pushes warm air through a flexible hose into a blanket draped over a patient. Warming blankets can recirculate contaminated air over a patient's body, including over an open surgical site. This may result in infections like MRSA or sepsis. In particular, patients undergoing knee or hip replacement surgery are at risk of infections deep in the joint. Complications from these infections include hospitalization, implant revision surgery, limited mobility, permanent disability, amputation and death.
